Minutes accepted from last/2023 annual meeting

New Business:

Discussion about board member meeting with DES back in March 2024 regarding being considered a public water system (based on their interpretation of 25 people, 15 houses with 2.5 people/house).

DES- per chapter Env-DW part ENV-DW 405- Small Community Water System (CWS)

Cost estimates a minimum \$7000-\$10,000/yr, per year for testing under the new guidelines. (This does not include Second Wind's additional charges). Costs would include: field inspections q3 years, design approval for any modifications, emergency plan, consumer confidence reports, extensive administrative record keeping, etc

Additional attorney fees (Don contacted 3). 1 said no, 1 was \$1500 retainer, 1 had a \$5000 retainer

Annual household expected charges would be ~\$2000/year

Recommendation of the HOA Board of Directors is to dissolve the HOA (as opposed to splitting into 2 HOA's, which would also be very costly and require extensive re-surveying, new deeds/insurance policies, etc). Other options are to contest the findings we are a public water supply (bc we don't own the wells or property), or to seek a waiver. Neither of these would likely be successful. Recommendation to dissolve the HOA has been looked as by 2 outside lawyers who also felt this was the best route to take

Unanimous vote by all 12 households present tonight to move forward and dissolve the HOA. All households signed petition to dissolve. This will be notarized

Proposal made for a new designation as Ians Way Neighborhood vs "HOA" (affects title and paperwork, but all "rules"/covenants remain the same, water/field mowing responsibility, etc)

We will need to retain an attorney for all administrative/legal documentation, etc

Old Business:

Mowing schedule- continues as is, no changes to remainder of 2024 season PH1 needed a new generator, purchased for \$850 at the end of winter Stainless steel pipe replacement- in progress, \$3000 cost. Steve doing this work

New pressure switch required for PH1 \$40

Retention Pond- cleanup and maintenance. Ians Way had an "easement" created when the development was initiated in ~2003, that the city is responsible for any maintenance needed. We just need to keep a clear path direct to the pond so the city can access it
